Available in web based format, the **NEBOSH NC e-learning package** assists students in meeting the requirements of the **NEBOSH unitised syllabus** and preparing them for examination.

The **NEBOSH NC e-learning package** is designed for either the single or multiple user and comprises of the following units:

- NGC1 Management of health and safety**
- NCC1 Managing and controlling hazards in construction activities**
- NCC2 Construction health and safety practical application**

Note: Students who have already been successful in attaining the NEBOSH National General Certificate within the last 5 years need only purchase Unit NCC1 of the package. (Please refer to the booking form on the reverse for costs).

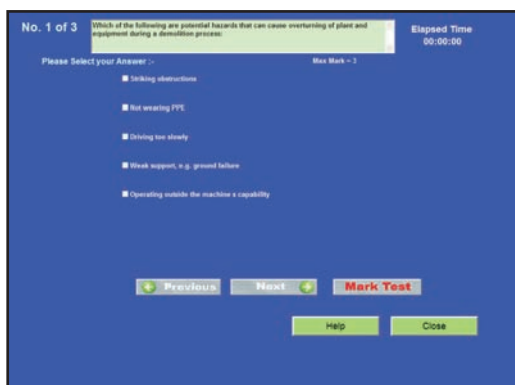

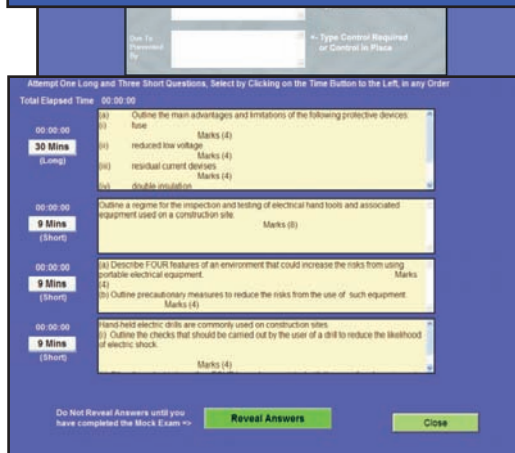
Against each unit, the package is divided into individual '**Elements**' to mirror the **NEBOSH syllabus** and each element has its own index, which references the syllabus content headings.

Users are easily able to move between the different elements with the buttons being clearly labelled and visible; they may also go back over the pages of information for further reference. The active time spent in each of the parts is timed by the application and is accessible by the user so that progress can be monitored against suggested study hours.



➤ Each element is then supported by **Multi-Choice Questions**, Personal Development Questionnaires (PDQs). Each question entry is marked by the application and a score is given. Success in this section allows users access to the Hazard Spotting and NEBOSH mock revision sections.

➤ **Hazard Spotting** tests are also available. Users are able to see the suggested answers and compare their own observations with the tutor answers. **These skills are required for successful completion of Unit NCC2 Construction health and safety practical application - the practical component of the NEBOSH Certificate in Construction.**



➤ A computer based **NEBOSH Mock Examination** test allows users to 'sit' a mock exam under time constraints. Users have to attempt one long question (30 min) and three short questions (each 9 min). Once complete, users are able to see the suggested answer and compare their own observations with the NEBOSH suggested answers. Practice at mock exams should help users to better manage their time apportionment and enable success in examination. **These skills are required for successful completion of the two written examination components of the NEBOSH Certificate in Construction (Units NGC1 and NCC1)**

Hazard Spotting Video. Once you have completed all of the elements, element 5 (NGC1) has an additional tab called Hazard Spotting Video, this is an additional test which can be repeated as often as you like.

All data entered, together with timings where appropriate, in the four sections (Multi-choice, Hazard Spotting, NEBOSH Mock Exam and Hazard Spotting Video) are recorded by the application.

The **NEBOSH NC e-learning package** is a thorough integrated software solution offering appropriate reference material reinforced by effective revision tests and mock examinations. Supported by a manual and optional e-mail support (by experienced tutors for 12 months from purchase date, subject to conditions).

Also available - **NEBOSH Study Book** for the National Certificate in Construction - £25.00 each + packing and carriage, if purchased with e-learning package (usually £29.95). Students usually purchase this as a supplement, it provides similar content to the web based e-learning option but in book format.

ACT is a registered **NEBOSH Examination Centre** eligible to receive external and open learning candidates. To register for your examination through us - contact the ACT Enquiry Team for assistance.
